## DISCIPLINE – SETTLEMENT AGREEMENT

Settlement Agreement - Narin George Singer, D.P.M., Case # 2018-26316 – Dr. Block is recused. Narin George Singer, D.P.M. was not present when his case was presented and was not represented by legal counsel. Mr. Judson Searcy reads case into record. **(TS – 03:28 Minutes)**



Mr. Judson Searcy explains that the terms of the settlement agreement are that Dr. Singer would appear before the Board but has been in contact with the Board office and explained that he now lives in the State of Washington. He explains that in the past, the Board has the ability to waive his appearance. Ms. Norr confirms the Board's ability to waive his appearance. Ms. Hartman notes that the Board has a copy of the letter from Dr. Singer notifying the Board and Board staff of his residency in the State Washington.

Dr. Oringer application came before the board earlier this year as he failed to pass part III of the exam and is required to come before the board to discuss educational guidance before being permitted to sit for the exam again.

Dr. Oringer is sworn in.

Dr. Oringer speaks on his behalf. He explains that he went down to Barry University and acquired a tutor that tutors people who are taking these exams. He uses her three hours a week, and has a letter from her. Ms. Norr explains to the Board that they are required to recommend certain areas of study or courses for the applicant to take to assist them in passing the exam.

After discussion, the following action was taken:

Dr. Sadri inquires as to what besides the tutoring that Dr. Oringer is doing to prepare for the exam. Dr. Oringer explains that he and his associate studies about six hours a day, five days a week, sees the tutor three days a week, and is also doing additional CME credits. Dr. Block



comments and confirms how many times he has taken and failed the exam. Ms. Norr asks if the Board wanted to ask about specific areas he may need help in or if they would like to recommend any education course for Dr. Oringer to take. Ms. Hartman references s.461.003(2)(b), F.S. Ms. Hartman confirms that the Board is considering accepting Dr. Oringer's current efforts as sufficient to satisfy the statute requirements of additional educational requirements.

Ms. Norr and Ms. Hartman review additional elements required for the Board to review relative to Dr. Oringer's malpractice history. Dr. Block comments and states he has an appreciation for what has happened in the past and where his is now has no further questions for the candidate and is comfortable with where we are at. Dr. Sadri has no further questions. Dr. Morris concurs.

Ms. Hartman also reviews Dr. Oringer's criminal history and asks Board to entertain motion for all three matters; approval to sit for exam part III, review of malpractice, and review of criminal history. Dr. Block confirms that his previous statement that he is comfortable with where we are at included his review of Dr. Oringer's criminal history.

Dr. Block makes statement regarding the frequency of applications that had questions that were not truthfully or incorrectly answered. References other Boards that have stricter policies addressing application errors where applicants were denied licensure for completing an application with erroneous or incorrect information, and notes that future cases of similar occurrences could have the same outcomes within this board. Dr. Block also references the boards leniency and understanding in approving applications with criminal history and would like to go on record stating that future, similar behavior may not have a favorable outcome for the board approving what the applicant is asking for, especially if the same applicants come before the board.

Dr. Sadri comments and asks if we can modify the application with some sort of declaratory statement to reiterate that applications need to be completed truthfully and accurately. or procedure to help.

Ms. Norr comments that the boards statements on the record today are valid but is uncertain this kind of statement can be placed on the applications and refers to Ms. Hartman for comment.

Ms. Hartman notes that the application already has general statement that does require the applicant to provide true and factual information, and the applicant does sign when they apply. The Board office will review possible language to strengthen the message the board has addressed today.
